## GAMES OF SKILL MACHINES

### DISTRIBUTOR OPERATOR LICENSE APPLICATION INSTRUCTIONS

#### What is a Game of Skill Machine?

A Game of Skill Machine is a mechanical or electronic gaming device that rewards the winning player or players with cash, a gift card, or a voucher that can be redeemed for cash. A Game of Skill involves a game whereby the player's skill, not chance or luck, is the determining factor on whether the player wins or loses.

In accordance with the Act, each Distributor must obtain a license from the OLG to sell, lease, or operate Games of Skill Machines in the District.

The OLG regulates Game of Skill (GOS) Machines throughout the District, licensing and monitoring these operations for compliance with District and federal laws and regulations. The following provides the license types and associated fees. All fees are due prior to the issuance of the license. In the case of Game of Skill Machines, the fee must be paid prior to the issuance of the OLG registration sticker.

Distributor- means a person/business who buys or leases GOS Machines, or any major components or parts of a GOS Machine, from Manufacturers for sale or lease and distribution to Retailers.

#### What documents are required to accompany a Distributor License Application in the District of Columbia?

- Basic Business License\*
- Clean Hands Certificate\*
- Enterprise Release Form\*
- Testing Lab Certification\*
- Government Issued Identification for All Owners\*
- Key Personnel Release Form (All Owners With 10%) \*
- Institutional Investor Certification (Attach One for Each Passive Investor With 10% Or More Interest) \*
- Ownership and Corporate Structure of the Applicant\*
- Internal Controls
- A written use agreement with a licensed Distributor for the placement or installation of a GOS Machines on the licensed establishment.

- **Business Name:** Is the official name of the person or entity that owns a company. And, it's the name you use on your government forms and business paperwork.
- **Business Trade Name or DBA Name:** A trade name may be the actual name of a given business or an assumed name under which a business operates and holds itself out to the public.
- **FEIN:** Is a unique nine-digit number assigned by the Internal Revenue Service to business entities operating in the United States for the purposes of identification.
- **GoS License Number (Renewals Only):** A number issued by the District of Columbia to operate Game of Skill services in a licensed establishment. A licensed establishment means an on-premises Distributor establishment licensed by the Alcohol Beverage Regulation Administration ("ABRA") to sell, serve, and allow for the consumption of alcoholic beverages.
- **Business/Cellular Phone Number:** Is a phone number used to connect with customers based on a local city, area, or state. This local phone number starts with the area code and makes it comfortable for local customers to connect with your business.
- **Business Address:** Is an address that is used to designate your principal place of business. It is where your business is supposedly operating from but may not always be the case. The address is used for communicating with your customers and vendors.
- **City:** Self-explanatory.
- **State:** Self-explanatory.
- **Zip Code:** Self-explanatory.
- **Ward:** A ward is an administrative division of a city or borough that typically elects and is represented by a councilor or councilors. <https://planning.dc.gov/whatsmyward>

- **Business Mailing Address(If Different):** Self-explanatory.
- **City:** Self-explanatory.
- **State:** Self-explanatory.
- **Zip Code:** Self-explanatory.
- **License Number:** A business license allows you to legally conduct business in your state, city or county. A tax identification number (or employer identification number) is used to identify your business for tax purposes.

**\*Note Every Institutional (Passive) investor with 10% or more interest in the applicant must complete an Institutional Investor Inform.**

This creates a limited liability for all owners, but results in a double taxation on profits (first as a corporate income tax, then as a personal income tax when the owners take their profits).

### **License Conditions:**

- **Clean Hands:** The District of Columbia "Clean Hands" mandate (D.C. Code § 47-2862) stipulates that individuals and businesses are to be denied City goods or services (e.g. licenses, permits, grants, contracts) if there is a debt owed to the District of Columbia of more than \$100 for fees, fines, taxes, or penalties; and/or failure to file required District tax returns.
- **Game of Skill:** A Game of Skill Machine is a mechanical or electronic gaming device that rewards the winning player or players with cash, a gift card, or a voucher that can be redeemed for cash. A Game of Skill involves a game whereby the player's skill, not chance or luck, is the determining factor on whether the player wins or loses.
- **OLG Indemnification Notice:** As Condition of the licensure, the applicants must agree to indemnify and to save harmless the district of Columbia against any and all actions, claims, and demands of whatever kind or nature that the District of Columbia may incur by reason of or in consequence of issuing a Game of Skill license to the licensee.

### **Credit Check and Release Information:**

- **Background Check:** Background checks provides OLG the opportunity to check a person's criminal record, education, employment history, and other past activities to confirm their validity.
- **Credit Check:** is a record of a person or business credit-to-debt ratio and shows how someone has managed credit and bill payments in the past.
- **Release of Information:** Is a document signed by the authorizing person owner, allowing the recipient or holder of the information to disclose or use the information through the consent of the owner.
