- (1) D.C. Municipal Regulations, Title 30 § 2106, allows for the issuance of a Provisional Sports Wagering License if the Applicant provides, among other requirements, proof of full current licensure for sports wagering, in the same category or equivalent category of license as being applied for in the District, from an Office of Lottery and Gaming (Office) approved jurisdiction.
- (2) Maryland Live! Casino & Hotel Maryland d/b/a S&S U Street, LLC (Maryland Live), has requested to add the State of Maryland (Maryland) to the Office's list of approved jurisdictions.
- (3) The Regulation and Oversight Division has reviewed Maryland Live's request to add Maryland to the list of approved jurisdictions. On May 31, 2023, the Director of the Regulation and Oversight Division (Division Director) issued a Memorandum recommending that Maryland be added to the list of Office approved jurisdictions for purposes of Provisional Sports Wagering Licensing. Additionally, for administrative clarification, the Division Director has recommended that the District of Columbia also be added to the list.
- (4) After a review of the Division Director's Memorandum, the Executive Director adopts the Recommendation in its entirety and finds that there is good cause to add the District

- of Columbia and Maryland to the list of Office approved jurisdictions for purposes of Provisional Sports Wagering Licensing.
- (5) Based on the foregoing it is **ORDERED** that the District of Columbia and Maryland be added to the list of Office approved jurisdictions that qualify applicants to apply for a Provisional Sports Wagering License. For purposes of 30 DCMR § 2106, following is the complete list of Office approved jurisdictions:
