**DC LOTTERY'S
BATTLE OF THE REAL HU
PLAYERS' CLUB TICKET GIVEAWAY
OFFICIAL RULES**

1. **CONTEST RULES.** These rules govern the Office of Lottery and Gaming's ("DC Lottery") **BATTLE OF THE REAL HU PLAYERS' CLUB TICKET GIVEAWAY (Contest)**.
 - A. By entering the Contest or by accepting a prize awarded through this Contest, each Contestant and Winner agrees to be bound by these rules.
 - B. No purchase is necessary to enter the Contest or to win a prize in the Contest.
2. **PROMOTIONAL PERIOD.** The Contest will begin on September 11, 2026 at 12:00:00 AM and ends on September 15, 2026 at 11:59:59 PM.
3. **ELIGIBILITY.** Entrant must be eighteen (18) years of age or older. Entrant must reside in the Washington, DC Metropolitan Area (as defined by the U.S. Office of Management and Budget and includes the Washington, DC-Arlington-Alexandria, DC-VA-MD-WV statistical area). Officers and employees of the DC Lottery and their relatives living in the same household, and DC Lottery contractors are not eligible to participate in the Contest and are not eligible to receive a prize awarded under the Contest. Void where prohibited by law. All entries are subject to laws and regulations governing the DC Lottery. Any entry deemed inappropriate or unsuitable, at the DC Lottery's discretion, will be disqualified.
4. **HOW TO ENTER.** During the Contest Promotional Period Entrants to the Contest must:
 - (1) Be a registered DC Lottery Players Club Member.
 - (2) Complete the DC Lottery Players Club Membership must include their first and last names, email address, date of birth, mailing address, and confirm that their information is correct and submit the form for entry into the Contest.
 - A. Participants must complete all two (2) steps in order to receive an entry into the Contest.
 - B. Participants may enter and or win only once.

- C. If you do not have a Players Club Membership, you may sign up for a free account at <https://dclottery.com/players-club-0> or [Players' Club | DC Lottery](#). By submitting your information and creating a Players Club account, you will be required to agree to DC Lottery's terms of service and privacy policy. If you do not agree to the terms of service and privacy policy, you cannot create an account or participate in this Promotional Contest.

5. **DRAWING AND PRIZES.** The DC Lottery will conduct a Drawing to be held on the date listed in the chart below to determine the five (5) winners and two (2) alternates for ("The Battle of the Real HU") Howard Bison vs Hampton Pirates Football Game tickets at Audi Field in D.C on October 3, 2026.

6. **WINNER AND ALTERNATE NOTIFICATION.** The Potential Winner will be notified via email for the Drawing on Wednesday, September 16, 2026. There will be two (2) Alternates selected for this Contest.
7. **CLAIM PERIOD.** Please refer to the chart below for Drawing Claim Periods for Winners and Alternates.

8. **INDEMNITY AND RELEASE.** By entering the Contest or by accepting a prize awarded through this Contest, each Entrant agrees to release, indemnify and hold harmless the District of Columbia (“District”), the DC Lottery and their officers, employees, agents, representatives, co-promoters, advertising agencies, contractors, from liability for any claims arising out of, or related to this Contest.
9. **ACCEPTANCE AND RELEASE FORMS.**
 - A. To claim the prize, each Winner must complete the winner claim process Affidavit which will be attached to the notification email and reply to the email attaching the completed form or email completed Affidavit to the DC Lottery at “angela.copeland@dc.gov” from the times indicated in the Claim Period section listed above. Potential Winner must complete all claim forms and releases required by the DC Lottery in order to claim their prize. Prize must be claimed by the final date shown in the Claiming Period or the prize will lapse and be forfeited.
 - B. To claim the prize, each Alternative Winner(s), if any must complete the winner claim process Affidavit which will be attached to the notification email and reply to the email attaching the completed form or email completed Affidavit to the DC Lottery “angela.copeland@dc.gov” from the times indicated in the Claim Period section listed above. Alternate Winner(s) must complete all claim forms and releases required by the DC Lottery in order to claim their prize. Prize must be claimed by the final date shown in the Claiming Period or the prize will lapse and be forfeited.
 - C. Winners and or Alternate that successfully claimed their prize will receive an acknowledgement message (via email message) along with instructions on how to electronically receive their tickets. The DC Lottery is not responsible for lost, delayed, or undeliverable prizes and failure to receive prize may result in prize forfeiture. Unclaimed Prizes will be forfeited.
10. **PRIZES AND OTHER RESTRICTIONS.** Odds of winning any prize depend on the number of entries received. The DC Lottery and its representatives reserves the right to substitute prizes. A prize is not transferable once the winner has claimed. Winnings valued at more than \$600 will be reported to federal, state and District tax agencies.
11. **LIMITATIONS OF LIABILITY.** This Contest is in no way sponsored by or affiliated with Howard University and Hampton University. All decisions regarding the Contest including, without limitation, winner selection, disposition of a prize, payments of taxes, selection of alternates, photograph suitability for public display, application and interpretation of promotion rules, resolutions of any dispute, drawing or promotion eligibility shall rest solely with the Executive Director of the DC Lottery or his/her designee (“Executive Director”) and shall not be subject to appeal. The Executive Director

may change the time and location of the drawing or contest prize and determine a default prize of comparable value to be awarded by the winner(s). The promotion is subject to cancellation at any time. 12. **GOVERNING LAW AND VENUE.** This Contest shall be governed and construed in accordance with the laws and regulations of the District of Columbia. Venue shall be in an appropriate agency or court of jurisdiction located in the District of Columbia.
13. **ENTRIES TO REMAIN THE PROPERTY OF THE DC LOTTERY.** All entries shall remain the property of DC Lottery and may be destroyed. No entries will be returned to Contestants.
